





### PRINT SPECIFICATIONS

#### **Deadlines**

Space Reservations due by the 15th of each month **PRIOR** to publication. Ad copy must be received no later than the 20th at 5PM

#### **Placement**

• Placement Guarantee: add 15% (min 1/4 pg)

#### **Ad Production**

Ad design billed at production rate of \$75 per hour. Basic ad production (15 mins) is free.

#### **Electronic Ad Submissions**

To ensure proper reproduction of your ad, please adhere to the following guidelines when preparing electronic files. *Oregon Family* is not responsible for printing errors resulting from failure to follow these guidelines.

- Ads must be built to dimensional size specifications on rate card.
- Preferred file type is a high resolution (300dpi) PDF digital file with fonts embedded.
- All body text should be 100% black—no color in small type. White type that reverses out of a color background should be bold, and at least 8 pt.
- Full bleed ads: 1/4" bleed on all sides, no trim marks.
